I will read Part II of this agreement, and will be responsible for obtaining all of the information required by that section. I will make no misrepresentations to the ski shop regarding the user's height, weight, and age or skier type.

I understand that **ALL FORMS OF SNOW-SLIDING**, including skiing, snowboarding and lessons, are **HAZARDOUS** activities. I also understand that all forms of snow-sliding, including terrain features and jumping, have **RISKS OF INJURY, INCLUDING DEATH**, that reasonable care, caution, instruction and expertise cannot eliminate. I further understand that injuries are common and ordinary occurrences during these activities. I **hereby agree to freely, voluntarily and expressly ASSUME and accept any and ALL RISKS** of any injury to any part of the user's body while engaging in any form of snow sliding.

I understand that the Alpine ski equipment being furnished by **China Peak Mountain Resort, LLC** or by any of its agents, employees, or affiliated corporations (**hereinafter collectively referred to as "CPMR"**), forms all or a part of a ski-boot-binding system which will **NOT RELEASE OR RETAIN AT ALL TIMES OR UNDER ALL CIRCUMSTANCES**. I further agree and understand that any ski-boot-binding system does **NOT ELIMINATE THE RISK** of injuries to any part of the user's body. If any Snowboard is being furnished, I understand that these systems are designed to **NOT RELEASE** and do **NOT PROTECT** against injuries to any part of the user's body.

I understand that **SURFACE CONDITIONS** on roads, parking lots, walkways, stairs and any other area exposed to the elements of nature are subject to the deposit, melting and refreezing of snow, rain, sleet, hail and ice, and the presence of sand, cinders or gravel, any of which may also be tracked on to interior surfaces, such that **WALKING OR OTHER DAILY ACTIVITIES**, particularly in ski boots or snowboard boots, may become **DANGEROUS**. I **FREELY ASSUME ANY AND ALL RISKS** of surface conditions, **INCLUDING THE RISK OF ANY NEGLIGENCE OF CPMR**.

CPMR provides **NO WARRANTIES**, express or implied. This equipment is accepted **"AS IS"**. I will accept full responsibility for the care of the listed equipment. I agree to return all rented equipment by the agreed date to avoid any additional charges.

I hereby **FOREVER RELEASE CPMR**, as well as the equipment manufacturers and distributors from, and agree to forever **indemnify them and hold them harmless** for, any and all responsibility or legal liability for any injuries or damages to any user of any equipment rented with this form, whether or not such injuries or damages are caused by the **NEGLIGENCE OF CPMR**. I agree **NOT** to make a claim against or sue **CPMR**, or any of the equipment manufacturers and distributors for injuries or damages relating to or arising from: the use of chairlifts or surface tows, any snow-sliding activities and/or the use of any rented equipment. I accept full responsibility for any and all injuries or damages, whether while walking or snow sliding.

Participant (and Guardian if Participant is a minor) hereby represents they are physically able to participate in snow sliding activities and authorizes any medical treatment deemed necessary in the event of any injury occurring while at China Peak Mountain Resort. **Participant (and Guardian if Participant is a minor) either has appropriate insurance or, in its absence, agree to pay all costs of rescue and/or medical services as may be incurred on my/our behalf.**

Participant (and Guardian if Participant is a minor) grants permission to **CPMR** to use Participant's image appearing in any photographs, videotape, motion picture or any other media for any of **CPMR's** advertising or promotional purposes whatsoever, in perpetuity throughout the world.
